Minutes

The regular BOCC meeting minutes from April 6, 2020 and the Special Meeting Minutes from April 9, 2020 were presented for approval.

Commissioner Cook made a motion to accept the above-mentioned minutes.

Agenda

Commissioner Cook made a motion to accept the agenda with the additions of approving a letter of support for the Cares Act funds distributions and a Public Health update from the Public Health Department.

Social Services Update

New Business

Dunton Hot Springs Liquor License Application Approval: Commissioner Kibel asked Sheriff Wilson if he had any concerns or issues with renewing the Dunton Hot Springs Liquor License. Sheriff Wilson stated that the compliance had never been an issue and they were great to work with.

Commissioner Garchar made a motion approving the Dunton Hot Springs Liquor License application.
Commissioner Cook seconded the motion.
All three Commissioners voted in favor of the motion.

Fire Ban Discussion: After discussion, it was decided to not enact a fire ban at this time to allow farmers to burn in draws and ditches and other residents to burn limbs. Public responsibility is key. Red flag burn recommendations should be followed as wind directions continually change. Sheriff Wilson discussed ticketing and fines for burns that get out of control during unsafe burning conditions. The Dove Creek Fire Department is available to schedule times for controlled burns, which allows valuable training for firefighters.

Cooperative Law Enforcement Annual Operating Plan and Financial Modification Agreement Approval: Sheriff Don Wilson gave a brief summary of the changes in the document from previous years.

Commissioner Garchar made a motion to sign the above-mentioned document.
Commissioner Cook seconded the motion.
All three Commissioners voted in favor of the motion.

Old Business

Cahone Park Gazebo Construction Decision: County Administrator Daves requested that steps be taken to continue with the gazebo bidding process. After discussion, a workshop was planned to decide on a size and location for the gazebo at the Cahone Park.
