Argon Plant Land Development Agreement

The presented Land Development Agreement for the Argon Plant was the previously viewed and preliminarily approved Agreement, including the Road Mitigation Plan. The version presented for execution contains clarification that the Agreement shall be effective through reclamation.

Commissioner Cook made a motion to approve the Argon Plant Land Development Agreement, including the Road Mitigation plan.

Sue McWilliams Property Use Discussion/Department of Ag Grant

Sue McWilliams presented to the BOCC her goal and vision for an Agrivotaic Research Project. The goal of the project is to demonstrate that solar farms, dryland crops, and pollinators can not only be compatible but can benefit and enhance each other, preserving farmland and filling our nation's renewable energy goals and needs, while mitigating drought and climate change. This business model is multi-faceted, providing multiple benefits by using the land for several purposes simultaneously. Solar developers and our country's energy demands benefit from the electricity produced by the solar panels, bees gain resiliency from a diverse source of pollen and wind protection which increases bee health and honey production, and landowners continue to utilize the farm ground for crops, seeing a positive impact from improved soil health and erosion control. Ms. Williams seeks to install 99-108 solar panels (agreed upon number with Empire Electric) on non-irrigated farmland in Dolores County. Two to four rows of panels would be installed on ground mount solar frames, low to the ground to mitigate wind damage. Fencing would be installed around solar fields to avoid damage from wildlife. Total research area is expected to be approximately 100' x 100'. All electricity generated would be purchased and utilized locally by Empire Electric.

Proceedings to the BOCC Meeting on October 31, 2023

The BOCC determined this needed to go to the Planning Commission to determine if the request constitutes a new development or a land use change, or if the project is exempt as agricultural or residential. If the Planning Commission determines that this project is exempt, Ms. McWilliams does not need to return to the BOCC.

Executive Session

Attorney Golbricht requested an executive session pursuant to CRS 24-6-402(4)(b) to provide an update regarding potential litigation. It was his opinion that the matters constituted privileged attorney communications and therefore no minutes or recordings would be kept. The executive session began at 10:40AM. No decisions were made.

Commissioner Cook made a motion to move to executive session at 10:40AM. Commissioner Yellowman seconded the motion.

All three Commissioners voted in favor of the motion.
