Dolores County Assessor Updates/Amber Blackmore

Dolores County Assessor Amber Blackmore updated the BOCC regarding assessed value and protest information. The assessed value for Dolores County as of July 7, 2025 is \$98,525,376.00. There was a total of 28 Real Property Value protests submitted to the Assessor's Office. Of those 28 protests; 7 have been approved, 14 denied, 4 satisfied and 3 are still active. There was 1 Personal Property Protest which has been approved. Denied protests can be submitted by the property owner for appeal with the Dolores County Board of Equalization. Those requests must be filed to the BOCC by mail, hand delivered letter to the Commissioner's office, or by email on or before July 15, 2025.

Dunton Hot Springs Land Acquisition Letter of Support

Dunton Hot Springs, along with Pete Johnson from the Conservation Fund, visited with the BOCC regarding the land acquisition of the two pieces of property being sold by Dunton Hot Springs to the Conservation Fund. This would be the "Fall Creek" and "Lizard Head Mesa" property. Once the land is transferred to the San Juan National Forest, these lands will gain additional protection for wildlife, recreation, and our watershed. In September of 2024 the same request for a letter of support was made; this would just be a renewal type of support letter.

Commissioner Stiasny made a motion to approve a letter of support from Dolores County in support of the Dunton properties land acquisition.
