Dove Creek Ambulance District Ballot Issue

SHALL DOVE CREEK AMBULANCE DISTRICT TAXES BE INCREASED BY \$550,000 ANNUALLY (\$225,000 IN 2025) AND BY WHATEVER AMOUNTS ARE RAISED ANNUALLY THEREAFTER FROM A SALES TAX TO COMMENCE ON JULY 1, 2025 AT A RATE NOT TO EXCEED 2%, SUCH SALES TAX TO BE IN ADDITION TO ALL OTHER TAXES LEVIED BY THE DISTRICT, WITH THE THE PROCEEDS OF SUCH TAXES USED BY THE DISTRICT FOR EMERGENCY SERVICES, MAINTENANCE, REPAIRS, SUPPLIES, AND OPERATING COSTS INCLUDING, BUT NOT LIMITED TO: AVOIDING SERVICE LEVEL CUTS AND MAINTAINING EMERGENCY RESPONSE TIMES; IMPROVING RESPONSE TIMES IN DEFICIENT AREAS; PROVIDING ESSENTIAL SAFETY AND COMMUNICATIONS EQUIPMENT, AND CAPITAL IMPROVEMENTS INCLUDING REPLACEMENT OF AGING EMERGENCY RESPONSE VEHICLES, REPAIR AND MAINTENANCE OF THE EXISTING DOVE CREEK AMBULANCE DISTRICT FACILITIES AS WELL AS THE CONSTRUCTION OF ADDITIONAL FACILITIES TO MAINTAIN CRITICAL INFRASTRUCTURE FOR CURRENT AND FUTURE COMMUNITY NEEDS?
